
IA case on Spotify



Seven overlapped countries comparing the top 10 Global Competitiveness vs. NIC ranking








National Intellectual capital for long-term wealth creation

- Global tangible resources are limited and depleting day by day, whereas intangible resources, such as knowledge, instead accumulate over time.
- The Nordics' secret recipe for success lies mainly in intangibles, including honesty, transparency, trust, individual rights, structural reforms, and human capital, based on *Economist* 2013 report.
- Will the Nordics maintain its status as "leader of the pack", or are there hidden complacencies that may drive performance downwards instead?
- We explored measurements and models for national intellectual capital, with specific application to Sweden.



- Lin and Edvinsson (Lin and Edvinsson 2008) developed a statistically validated 28-indicator model measuring national intellectual capital (NIC) based on data purchased from the Switzerland-based International Institute for Management Development (IMD).
- The NIC model was later modified and expanded to cover 48 indicators. This revised model, called the ELSS NIC model (Ståhle, Ståhle, and Lin 2015), removed outdated indicators (such as literacy) and included indicators reflecting current concerns (such as gender equality and freedom of speech).







Renewal Capital of Four Nordic countries and trend to 2020









Figure 23: Renewal capital of Sweden, Singapore, Israel and Switzerland and trend to 2020

An overall declining trend











National Intellectual Capital vs. GDP per capita (ppp) for 4 Nordic countries. Norway has the best progress







Both Denmark and Norway have good progress in NIC and GDP over the 16 years with a positive correlation.






Finland's NIC regressed a little over the 16 years, even though it has some progress in GDP.






Sweden's NIC and GDP have a little progress over the 16 years with a positive correlation.






Renewal capital of the 4 Nordic countries, Norway is picking up with the other 3 countries although it still lagged behind in RC


Renewal capital of Sweden regressed a little over the 16 years, with a slight negative correlation with GDP. The signal is as early as in 2002.






Renewal capital comparison between Sweden and 3 small countries (Israel, Singapore and Switzerland)






Sweden started out with a very high computer + mobile, yet surpassed by Norway in 2016





Sweden started out with a higher internet + broadband than Norway in 2001, yet surpassed by Norway in 2016






Sweden and Denmark had similar current account balance in 2001, yet Sweden was surpassed by Denmark in 2016







Sweden had the best government efficiency, yet was surpassed by Denmark in 2016 and Norway was catching up with Sweden in 2016





Sweden lagged behind Finland in utility patents/R&D expenditure






Sweden declined in venture capital, while Norway was catching up





Sweden was far ahead of Denmark in research articles, yet was surpassed by Denmark in 2016






Innovative capacity vs. GDP per capita (ppp) for four Nordic countries. Sweden has the best innovative capacity in 2016.




